

We had a fabulous presentation by Larine Chung this month. She started out by talking about 2020 as being the year of isolation and how that has affected her art. She made a personal history series, which she edits and changes as time passes until they are finished to her satisfaction.

She created a series of "Strong" for Tom Kroft from England. It is a series of portraits of frontline workers, who receive these as gifts in appreciation for their bravery and hard work.

She likes to paint from her imagination, and finds these works do not always turn out to be what she expected! However shows of these paintings have been received well. She went through a time where she enjoyed doing life size drawings of people to portray the intensity, which we can certainly see in the finished pieces.





Her experience in biochemistry has influenced the way she thinks and her methodical approach to painting. Today she demonstrated working with a limited palette. She always starts with a color mixing chart, which helps her work out her pigment choices, mixes and values. I like how her strokes are with purpose, and because she doesn't blend too much, everything is fresh and painterly.



LOCAL WORKSHOP NEWS

One of the consequences of this challenging year was not being able to enjoy each other's company and inspiration during local workshops. I hope that you have continued to create and venture into the art zone in some capacity! There are interesting art videos on several online venues you can explore: You-Tube, Netflix, Amazon Prime. Also, thanks to Scott Landry mentioning it to me, I'm now a regular every Thursday morning watching a free Zoom art presentation/slide show/demo ("Art Chat") from the Winslow Art Center, excellent by the way. I hope you will try some of these and also dip your brushes into your paint and experiment!

I am incredibly pleased to announce that Lauriel Sandstrom is now my partner for organizing local workshops. She has a wealth of experience and knowledge that she has shared with CoArts in many other capacities, as well as that famous laughter and warm personality. She will be taking the lead for the next workshop. We will venture into the online venue using Zoom, and it is likely over time that we will be offering more workshops using the online option. Meanwhile, details are being worked out for our very first class trying this method. The online watercolor workshop is targeted for a Spring session. Stay tuned for updates on description and signup.

The Jacqui Beck workshop using acrylic and mixed media entitled "Stretching Towards Abstraction" which was cancelled due to Covid-19 has been rescheduled for December 1-2, 2021, Wednesday-Thursday. This class had been filled and scheduled for March 2020. To inspire you, take a look at Jacqui's fabulous work here: jacquibeck.com
Be sure to watch her free instructional videos posted on the site.

I plan to begin sign-up for Jacqui's class in Fall 2021 contingent on the epidemic status. Covid-19 circumstances will continue to be monitored to see whether it becomes safe to conduct this in-person class (building open, vaccines taken, Phase 4 in King County). Should the need arise, a back-up date for the class is projected to March 3-4, Thursday-Friday, 2022. Information will be posted in the newsletter as the December date draws closer. Members who were previously signed up for the class will have priority sign-up for the reschedule. Any remaining spots will next be available to CoArts members for \$125. A scholarship may become available; contact the workshop chair privately if you wish to be considered.

NON-JURIED EXHIBITS.....

Several years ago, Seattle Co-Arts had the luxury of using the NW Hospital Cafeteria wall space and those of the Seattle Breast Office for displaying our great and varied artwork. It was "first come, first up", and a hanging and planning group hung the work. The work was shown for approximately three months. There was no jury to say yea or nay. It was up to the artists to decide which of their work was to be shown, hence "Non-Juried Show". It was a great opportunity. We received many good comments and often sold some of the work.

When University of Washington took over hospital facilities, they transitioned to permanent installations, and our opportunity vanished. Until recently each artist has been responsible to find their own place to show their work. We still encourage each artist to find their own locations or go with a group to show, as well as participating in the Seattle Co-Arts Annual Juried Show.

Recently we have been actively looking for locations to show for several months at a time and use their wall space. To be on this "location list," we hope for many viewers of the work, for secure locations reducing theft and damage, for opportunities for sales, for appropriate hanging space, and an agreement regarding hanging, either by us or by their workers.

Last fall we showed at the Evergreen Hospital East Wing corridor by their coffee stand. There were lots of passer-by and the display could be seen from outside of the Hospital. There were 40 works. The Hospital was responsible for hanging, but we were responsible for delivery. We had a lot of good feedback. There were to be two other locations...then the Pandemic happened and all was put on hold.

At this time, we have a Non-Juried Show planned for the months of April, May, June and July. We will be calling for 60 paintings, that is, six paintings from ten artists, or three paintings from 20 artists.

Lynn Kerr has started us off on the Non-Juried Shows, but has taken on other obligations and would like to find another more mobile Chairperson. The new Chairperson will be given the current list of possible venues and information already established. This is a perfect time to have a new person step in, as things are slow, stopped or closed. It is an enjoyable way to expose Co-Arts to new and exciting locations, and make new friends for the Seattle Co-Arts community. Please step up and take on this fun and exciting opportunity.



- Size: Paintings must not exceed 36 inches on any side, including framing. There is no required minimum size.
- **Presentation:** Art must be framed or have gallery wrapped or finished edges and be <u>ready to hang</u> with a wire on the back about ½ of the way from the top. No work with sawtooth hangers will be accepted.
- Work must be labeled: The back of each painting must be clearly labeled with your name, title of the work, medium, price and your contact information.
- Artwork will be judged on its aesthetic quality and appropriateness for public display. No frontal nudity is permitted in the show.

Prepare 1 high-quality, evenly-lit jpeg of each artwork submitted, cropped to exclude frame or background, to the following digital specifications: 300 ppi (pixels per inch) and 1800 pixels (6 in) on the longest side. If you cannot size your photos to this size, send the highest-resolution images you can, and Beth will resize them for you.
